PTO had their first meeting. There is a new chair of the playground committee. They discussed their normal fund-raisers. Any new fund-raisers requested by the PTO will be brought to the School Committee. They would like to do a new fund-raiser, a shirt with Brimfield's logo on it.

Mr. Valcour suggested that the Playground Committee do most of the leg work and puts everything together, then brings it to the school committee for approval. Mr. Malhert asked if the school committee would consider sending Senator Brewer a letter to ask for a playground grant. This worked for another community. Mr. Mahlert will put that together and bring that information to the school committee.
