Mr. Haggerty moved to adopt the all amendments to the Regional School District Agreement Between the Towns of Brimfield, Brookfield, Holland, Sturbridge and Wales with respect to the formation of the Tantasqua Regional School District except Section III and to submit these amendments to the Department of Elementary and Secondary Education (DESE) for their review.

- Because of this the revisions contained in this vote do not address the membership or the one-man- one-vote issue in Section III.

- OSV Charter School Dr. Nosek spoke with James Donahue, President/CEO of Old Sturbridge Village. He indicated that the plans are currently in the exploratory phase, but agreed to come before the Tantasqua Committee if they proceed. Mr. Galonek indicated that they have already hired a "Founding Principal" and as a member of the OSV Board of Trustees, he reported OSV is moving forward focusing first on elementary education.

He recommended that a meeting with the Sturbridge Elementary School Committee would be in order. Tantasqua will re-extend an invitation for the September meeting.
