1. MINUTES

**Motion 16-33:**

Ms. Ryan moved, seconded by Mr. Barnicle, to accept the regular session minutes of October 20, 2015.

2. FINANCIAL REPORT

Mrs. Boyd indicated the transfers voted at the October meeting are reflected in the Financial Report for the period ended October 31, 2015.

Mrs. Boyd reported the heating oil bid through the French River Collaborative came in at \$1.74/gal as compared to the current price of \$2.27/gal.

b. Budget – Mrs. Noyes-Miller reported the Subcommittee met last week to discuss the Central Office budget approved by the Joint Committee earlier in the evening. The Subcommittee is continuing its practice of holding meetings in each of the towns. This year, the subcommittee scheduled these meetings for the same nights and location as the elementary school committee meetings hoping to increase attendance. Meetings scheduled at 7:30 p.m. as follows: Burgess – 1/7/16; Brookfield – 1/12/16; Holland – 1/14/16; Wales 1/20/16 and Brimfield – 1/26/15.

d. Curriculum – Mrs. Barnicle reported the first subcommittee meeting was held 10/16/15. Three topics were discussed:

f. Negotiations – No report, but negotiations will be starting with three different units.

g. Building & Physical Plant - The subcommittee met 11/19/15 and discussed the athletic fields. The Committee hopes to come to the December meeting with a recommendation on the fields, tracks and making the press box handicap accessible. The next meeting is scheduled 12/7/15.

h. Regional Agreement Amendment Committee (RAAC) - Mr. Haggerty reported that DESE recommended some minor changes to the proposed amendments submitted. The changes are as follows:

- Page 2 - Section VI, D regarding the language for transportation making sure that the district is providing transportation, with a contract out to Sturbridge. This change will ensure costs affiliated with regional transportation are eligible for state reimbursement.
- Page 3 – Section X, D regarding (2) add: “and for post-employment costs of employees that retired while the town was a member,”
- Page 4 – Section XI – clarification of the 2/3rds vote.
- Page 5 – Section B – inclusion of the requirement that the Commissioner approve any future amendments.

Mr. Haggerty indicated that the RAAC doesn't know how to proceed with Section III of the agreement that deals with membership composition of the Tantasqua School Committee. There are complications regarding how to value counts by either registered voters vs. census numbers. The other sections of the agreement were in desperate need of updates to comply with current law and to reflect current practices. The RAAC unanimously voted to recommend approval of the proposed amendments and to submit the amended agreement with the exclusion of any changes in Section III to the member towns for their annual town meeting warrants.

**Motion 16-34:**

Mr. Haggerty moved to approve the proposed amended Regional School Agreement, excluding the current Section III-The Regional School District Committee, and submit the proposed amendments to our member towns for consideration at their respective annual town meetings.
