Mrs. Boyd stated that we received an initial quote of approximately \$45,000 for the water tank project. She requested that the school committee vote up to \$45,000 from School Choice money to get the project moving forward.

Karen Blasco made a motion, seconded by Ed Boyce, to appropriate up to \$45,000 from School Choice for the water tank project.

- The Southern Worcester County Collaborative is in the process of looking at the possibility of purchasing the property that currently houses the Grow Program, which would save money in the long run.
