# **TANTASQUA REPRESENTATIVE REPORT:**

There was a Tantasqua Regional School Committee meeting last night and there was a 30 minute discussion on the removal of books from the Tantasqua High School Library. There was an update from the Regionalization Agreement Amendment Committee regarding the revision of the regional agreement.

### **PUBLIC ACCESS:**

Michael Milanese, Board of Selectmen, informed the School Committee that they are considering moving the Cable Access Channel to the school. More information will be coming as the town investigates possible locations.

A parent asked a question regarding when the item of either a new school or regionalization would be brought forward. Mrs. Boyd stated that there is nothing on a regular basis that addresses the issue.

# **OLD BUSINESS:**

\* NEASC – Communication regarding postponement of Accreditation Visit to the fall of 2016.

Mrs. Deb Boyd stated that we received a communication to delay the NEASC Accreditation until the fall of 2016. There will be a discussion in January 2014 regarding the financial impact on the FY'15 and FY'16 budgets related to the accreditation process.

Motion by Ed Boyce, seconded by Susan Hubbell, to include the initial NEASC Accreditation costs in the FY'15 budget.

There were various questions from the members of the audience regarding the costs of the process. Ed Boyce stated that the cost of membership in NEASC is not free. A question was raised regarding the benefits of membership in NEASC as Wales is a Level 1 school as rated by the Department of Elementary and Secondary Education.
